Presentation of a study sponsored by the European Commission on SME manufacturing FDI in the SEE Region. This project focuses on Manufacturing Foreign Direct Investment (FDI) by European Union (EU) Small and Medium Sized Enterprises (SMEs) in the SEE, with the main elements pertaining to (1) mapping manufacturing FDI in WB, (2) economy-specific analyses, (3) analysis of main manufacturing sub-sectors, (4) analysis of 3 EU SME case studies in 3 economies, and (5) conclusions and recommendations, with a focus on the regional level. The WGI will receive information about the study, discuss prospective integration of the study recommendations into the work of the WGI and will also propose case studies of SME FDI for the purpose of analyses.
