- 3. Statistics of enterprises
- 4. Statistics of agriculture, forestry and fishing
- 5. Multi domain statistics

Bank of Albania is responsible for compiling: (www.bankofalbania.org)

- 1. BOP
- 2. IIP
- 3. GED
- 4. FDI (by economic activity and by country)
- 5. DTR

Both INSTAT and BOA are responsible for compiling FATS.

Characteristics of DI abroad:

- 1.DI abroad represents DI of the financial sector and other sector.
- 2. For other sector, stock is calculated as accumulation of flows. Commercial banks report on behalf of OS.
- 3. The information for the country or the sector where it is invested is not reported by the commercial banks, but DI abroad are mainly houses bought by Albanians in foreign countries (real estate).

FDI by economic activity

Bank of Albania compiles FDI statistics according to BPM5 and BPM6. FDI according to BPM5 are available from 2007 (2007-2013). FDI according to BPM6 are available from 2012 (2012-2013).

Characteristics of INFATS:

- 1.INFATS represents 95% of FDI.
- 2. For calculating INFATS is used the threshold of 50% of foreign capital.
- 3.Bank of Albania does not publish/ disseminate figures related to FATS.
- 4.Data used for the compilation of FDI are detailed data and they can be used also for FATS purposes.
- 5.BOA does not collect other qualitative data, necessary for calculating FATS variables.

Future plans

- 1. Conducting a quarterly FDI survey. (2015)
- Introducing an annual survey for collecting information on DI abroad. (2015-2016)
- 3. Collaborating with INSTAT for compiling FATS.
