Aim of the meeting:

The main objective of this workshop is to improve the trade relations between CEFTA Parties as regards the implementation of common market standards related to labelling of food of animal origin.

The major topics include: Compulsory and optional information on the label, designations of origin, geographical indications and traditional terms in the sector of food of animal origin, official checks, EU market standards related to the labeling of milk and milk products, meat, fish and aquaculture products, eggs, honey.
