

DECISION OF THE JOINT COMMITTEE OF THE CENTRAL EUROPEAN FREE TRADE AGREEMENT

No. 2/2025

Adopted on 6 March 2025

on the Electronic Exchange of Data concerning

Entry Authorisations for Groups of Medicines Containing Controlled Substances

The Joint Committee has decided as follows:

Article 1

Common Format for the Entry Authorisation for Medicines Containing Controlled Substances

CEFTA Parties commit to use the Common Format for the Entry Authorisation for Medicines Containing Controlled Substances provided in the Annex to this Decision and to electronically exchange the related data.

Article 2

Entry into force

This Decision shall enter into force on the day of its adoption.

Adopted in Pristina, on 6 March 2025, in the presence of representatives of all CEFTA Parties. This Decision was adopted by all CEFTA Parties in the presence of their representatives, except by Albania, which made a reservation regarding the fulfilment of its domestic legal requirements for the adoption of this Decision. This Decision shall be considered as adopted once Albania has confirmed to the Depositary that its domestic legal requirements for the adoption of this Decision have been fulfilled and shall enter into force in line with Article 26(2) of this Decision.
